1. The rate should be quoted for F.O.R. FCBL, Phuentsholing inclusive of all taxes and levies.
2. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
3. The FCBL will award the contract to the bidder whose quotation has been determined to be substantially responsive as per the terms & conditions mentioned and as determined by the tender committee.
4. The bidder whose bid is accepted will be notified through sending an awarding letter or phone call prior to the expiration of the quotation validity period.
5. The bids should be accompanied by a bid security of **Nu. 5,000.00** (Ngultrum Five Thousand) only, in the form of Cash Warrant/Demand Draft/Bank Guarantee in favor of FCBL, Phuentsholing without which quotation will be

- rejected outright. The bid security of unsuccessful bidders shall be discharged as promptly as possible upon award of contract.
- The successful bidder should furnish **Performance Security** of Nu. **10,000.00** (Ngultrum Ten Thousand) only, in the form of Cash Warrant/Demand Draft/ Bank Guarantee in favor of FCBL, Phuentsholing and shall be valid until successful completion of the deal.
 - The up to date copies of the valid trade license with a tax clearance certificate to be enclosed without which quotation will not be accepted.
 - If the firm totally fails in delivering the services during the contract period, the firm performance security shall be forfeited.
 - The regular preventive maintenance should be carried out by the bidder as and when there is requested.
 - If the firm fails to deliver any services within the time period specified in the work order, the FCBL shall impose a penalty as sum equivalent to 0.05 % of the contract price of delayed goods & services for each day.
 - The FCBL may procure any of the items from the open market as and when the supplier fails to deliver the item within the stipulated time and if the rate is higher than the quoted rate, the extra cost shall be deducted from their pending bills payment if any.
 - The FCBL reserves the right to reject or cancel any work order without assigning any reasons whatsoever.
 - 100% Payment shall be made only after satisfactory delivery of goods & services. Advance payment is not permitted.
