4. The earnest money deposit of the unsuccessful bidder shall be refunded immediately after the completion of the tender.

5. The earnest money of the successful bidder will be forfeited if bidder refuses to accept the tender.
6. The submission of the tender shall mean that the bidder have inspected the vehicles physically and have quoted the rate. Any complaints about the condition of the vehicle shall not be entertained at any cost later.
7. The successful bidder shall ensure that the ownership transfer of the vehicle is executed within 15 days as per the existing RSTA Rules and Regulations.
8. The ownership transfer cost or tax and any other vehicle-related costs shall be borne by the successful bidder.
9. If the offer price is found to be less than the reserve price of the vehicle, the bid shall remain cancelled or the FCBL management shall decide as deemed necessary.
10. The committee shall open the bids received and read the quoted bid amount to participant.
11. If there is a tie between bidders, then a lucky draw shall be held as "YES" to decide the ultimate winner or successful bidder.
12. The sum of Nu. 500 per day shall be imposed for the delay in the lift of the vehicle from the station.
13. A copy of the CID card shall be submitted along with the bid.
