#### **Invitation Bids**

- 1. The [Food Corporation of Bhutan Ltd] now invites sealed Bids from eligible and qualified Bidders for [Supply of Diary Books & Table Calendar].
- 2. Bidding will be conducted through the Open Bidding procedure specified in the RGoB Procurement Rules and Regulations, and is open to all Bidders from Countries as defined in Section V of the Bidding Documents.
- 3. Interested eligible Bidders may obtain further information from *Head (HRAD)* and inspect the Bidding Documents at the address given below [*Administrative Unit (HRAD), Phuentsholing*] from [9.00 A.M-5.00P.M.
  - Qualification requirements include: [Supplier who hold valid trade license, tax clearance certificate and financially sound]. A margin of preference for eligible national suppliers and joint ventures/ consortia/associations may be applied.
- 5. A complete set of Bidding Documents in *[English]* may be purchased by interested Bidders upon payment of a non-refundable fee of *[300.00]*. The method of payment will be *[Cash]*. The Bidding documents may be downloaded free of cost from purchaser's website <u>www.fcbl.bt</u> or available for sale from *6/10/2022 till 20/10/2022* from FCBL, Head Office Phuentsholing.
- 6. Bids must be delivered to the *Administrative Unit (HRAD), P/ling* at or before [20<sup>th</sup> Oct, 2022]. Electronic bidding [*shall not*] be permitted and late Bids will be rejected.
- 7. Bids will be opened physically in the presence of the Bidders' representatives who choose to attend in person at the address [*Conference Hall, FCBL, Head Office Phuentsholing*], dated: [20<sup>th</sup> Oct, 2022], Bhutan time: [11.30 A.M].



#### FCBL Management

- 1. The rate should be quoted for F.O.R. FCBL Phuentsholing inclusive of all taxes and levies.
- 2. The bids should be accompanied by a bid security of Nu.5, 000.00 (Five Thousand) only, in the form of Cash Warrant/Demand Draft/Bank Guarantee in favor of FCBL, Phuentsholing without which the quotation shall be rejected outright. The bid security of unsuccessful bidders shall be discharged as promptly as possible upon award of contract.
- 3. The successful bidder should furnish **performance security** of **Nu. 10,000.00** (Ten Thousand) only, in the form of Cash Warrant/Demand Draft/Bank Guarantee in favor of FCBL, Phuentsholing and shall be valid until successful completion of the deal.
- 4. The up to date copies of the valid trade license with a tax clearance certificate to be enclosed without which quotation will not be accepted

The quotation should be submitted as per the following instructions and in accordance with the attached Contract. The attached Terms and Conditions of Supply is an integral part of the Contract.

- *a*) PRICE: all prices shall be quoted in Ngultrum. The quoted price shall be inclusive of all related costs including taxes, duties and other levies to the final place of delivery. The final place of delivery is *Corporate Head Office, Phuentsholing* (FCBL).
- b) EVALUATION OF QUOTATION: offers determined to be substantially responsive to the technical specifications will be evaluated by comparison of their quoted prices. In evaluating the quotations, the purchaser will determine for each quotation the evaluated price by adjusting the price quotation by making any correction for any arithmetical errors as follows;
  - i. where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
  - ii. where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted shall govern unless in the opinion of the Employer there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line item total as quoted shall govern, and the unit rate shall be corrected.
  - iii. if the supplier refuses to accept the correction, this quotation will be rejected and the bid security shall be forfeited.
- c) AWARD OF PURCHASE ORDER: the award will be made to the bidder who is offering the lowest evaluated price that meets the specifications. The successful bidder will sign a contract as per attached form-2 of contract and terms and conditions of supply.



- d) VALIDITY OF THE OFFERS: your quotation(s) shall be valid for a period of *One Year* from the deadline for receipt of quotation(s).
- 5. Depending on the final requirement, the purchaser may increase or decrease the quantities by fifteen percent (15%) of the purchase order.
- 6. The quotation(s) will be opened in the presence of bidders or their representatives who choose to attend at the specified venue and time.
- 7. The Purchaser is not bound to accept the lowest bid and reserves the right to accept or reject any or all the bids without assigning any reason whatsoever.
- 8. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 9. Normal commercial warranty/guarantee shall be applicable to the supplied goods.
- Hundred percent (100%) of the Contract Price shall be paid after satisfactory delivery of goods to the final destination (Food Corporation of Bhutan limited, Phuentsholing).
- <sup>11.</sup> No advance payment shall be sanctioned.
- 12. The ten (10) percent performance security shall be retained as security deposit and paid at the end of the contract whichever is later after adjustment of dues if any.

Documents required to be submitted as part of the Quotation

The original and *copy (ies)* of quotation submitted by the supplier shall comprise the following:

- (a) A duly completed and signed priced quotation as per the Schedule of Items and the Priced Quotation.
- (b) A valid Trade License;
- (c) A valid Tax Clearance Certificate;
- (d) Bid Security
- (e) Technical Specification of the Goods to be supplied; and
- (f) Any other requirements specified in this document

#### Terms and Conditions for the Supply of Goods and Payment.

The Terms and Conditions hereinafter may only be varied with the written agreement of the Purchaser and no terms and conditions put forward at any time by the Supplier shall form any part of the Contract.

- 1. The Supplier shall be required to submit a performance security of 10% of the quoted price in the form of cash warrant, demand draft or unconditional Bank Guarantee issued by a financial institution located in Bhutan, which shall be furnished upon signing the contract. Performance security shall be valid till the end of warranty period and will be returned after the end of warranty period.
- 2. The supply of the goods shall be completed within [*state number*] days from the date of issue of the Purchase Order, or the signing of the contract (if applicable);
- 3. Payment of the Invoice shall be arranged by the Purchaser, within thirty (30) days upon submission of original Invoice and TPN number, against the actual supplied quantities of goods as listed in the Purchase Order.
- 4. The quoted price shall include all taxes, duties, insurance and any other costs involved and nothing extra shall be paid.
- 5. Any goods found defective during the warranty period shall be replaced/ repaired by the supplier at his cost. If the supplier fails to rectify and or replace the defective goods, the purchaser shall do it at the cost of the supplier.
- 6. The supplier shall pay liquidated damages at the rate of 0.1% per day for each day of delay to a maximum of 10% of the quoted price.
- 7. The Purchaser may, by written notice, terminate the Purchase Order (or Contract if applicable) in whole or in part at any time for its convenience:
  - a. if the Supplier fails to perform any other Terms and conditions specified with the Purchase Order, or exceeds the maximum amount of liquidated damages.

- b. if the Supplier fails to perform any other obligation(s) under the Purchase Order, or
- c. if the Supplier does not take any remedial action within a period of (7) seven calendar days after receipt of a notice of default from the Purchaser specifying the nature of the default(s), or
- d. if the Supplier, in the judgment of the Purchaser, has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this Purchase Order; and
- 8. The Supplier shall provide the warranty, as stipulated in the Quotation document, for the goods to be supplied and confirm that if any faults are detected within the warranty period in the supplied/installed goods, the Supplier shall be bound to rectify the fault or replace the goods as the case may be. The security deposit shall be used to cover the cost of supplies not delivered or defective items not replaced or rectified.
- 9. The purchaser may procure any of the items from the open market in case the supplier fails to supply the goods within the stipulated time and realise the difference amount between the quoted price & market price from the security deposit.
